Rebate Guidelines

- Rebates are only available to City of Ramsey utility customers with non-delinquent accounts.
- For single family residential properties, rebate maximum (per device) for toilet, smart irrigation controller, or clothes washing machine is up to \$200 or the cost of the device, whichever is less (excluding installation costs and sales tax).
- Rebates cannot exceed \$500 per single family residential address (allows for purchase of multiple devices).
- For commercial or HOA properties, rebate maximum (per device) for toilet is up to \$200 and for irrigation controller up to \$700 or the cost of the device, whichever is less (excluding installation costs and sales tax).
- Rebates cannot exceed \$1,400 per commercial or HOA address (allows for purchase of multiple devices).
- Each toilet and/or smart controller must be a **US EPA WaterSense** labeled product.
- Each clothes washing machine must be a **US EPA Energy Star** labeled product.
- Rebates available on a first come, first served basis.
- Documentation of qualification must be provided with application.
- **A photo(s) of the device being replaced** must be included with the rebate application.
- Original receipt (or a copy) must be provided with the rebate application.
- Device must be installed in home or business within Ramsey that is on the City's municipal water system.
- Rebates available for purchases made after May 1, 2020 and through June 30, 2022, or until funds are gone, whichever occurs first. It is the responsibility of an applicant to verify whether funds are still available or not.
- The City reserves the right to inspect the property to ensure installation of the device(s).
- The City reserves the right to amend or terminate this grant program at any time.
